### **REQUEST FOR QUOTATION (RfQ) no. 53/2017/M/CELONKO**

In relation to the planned implementation of the project Development of novel biomarkers and innovative FGFR kinases inhibitor as an anti-cancer therapy by Celon Pharma S.A. as part of the 2nd edition of the contest in the research and development program Prevention and treatment of civilization diseases - STRATEGMED (hereinafter "the Project"), we hereby request your quotation for:

#### **Subcontracting: Selectivity screen against a broad panel of receptors and proteins that may mediate off-targets effects – *in vitro***

- a. The screen needs to be performed *in vitro*, as a functional assay (in cell lines or on the receptors)
- b. The results need to be submitted as percent of inhibition or activation compared to the control
- c. The screen should include at least 44 selected targets, recommended by 4 major pharmaceutical companies according the publication (Bowes, J., Brown, A. J., Hamon, J., Jarolimek, W., Sridhar, A., Waldron, G., & Whitebread, S. "Reducing safety-related drug attrition: the use of *in vitro* pharmacological profiling; Nature Reviews. Drug Discovery (2012), 11(12), 909–22. <http://doi.org/10.1038/nrd3845> page 913-915 (tabela 1).)
- d. The assay should be conducted in duplicates or triplicates for a single target protein, in single-pointed concentration of the compound.
- e. Expected turnover time: 30 days for executing a given order (starting from the moment of receiving the compound(s) by contractor and ending at the moment of the final report delivery)
- f. On demand, the contractor should present raw data from the experiment.

The experiment is planned for 1 compounds. The order reserves the right to change the number of testing compounds.

The study will be ordered between October 2017 and December 2017 based on a purchase order prepared by client.

**Requirements to be met by bidders:**

1. The Bidder should have the necessary experience to deliver the subject of the order.
2. The Bidder should hold all licences required by law to deliver the subject of the order.
3. The Bidder's financial and economic position should ensure successful implementation of the order.

**Address and date for submitting the bids:**

2. Bid must be submitted by the **18 October 2017** at the latest.
3. Bids submitted after the aforementioned date will not be considered.
4. Bids will be evaluated at the Purchaser's office within 7 days from submission deadline.
5. The final decision will be communicated to all Bidders by electronic mail within 7 days from submission deadline.

**Presentation of the bids:**

1. Each Bidder may submit only one bid.
2. The bid must contain the date of preparation, the Bidder's address, telephone number, email address, tax ID number.
3. The bid must be valid until the end of the year 2017.
4. The bid must contain:
  - if submitted by a Bidder operating in Poland, the gross and net bid price and due VAT offered for delivery of the subject of the order on accordance with the requirements set forth herein,
  - if submitted by a Bidder operating outside Poland, the net bid price and information that not VAT or other taxes have been included in the price quotation.
5. The bid should contain the RfQ no. in the title. The RfQ no. must also appear in the titles of invoices.
6. "The Statement on absence of personal or capital ties with the Purchaser" should be submitted along with the bid.

**Note:**

1. The Purchaser will place the order with the bidder whose bid meets all the requirements set forth in this RfQ and is deemed the best relative to the selection criteria set forth herein.
2. The Purchaser reserves the right to close the bidding process without selecting the successful Bidder. In such case the purchaser doesn't need to specify its reasons for doing so.
3. In the course of evaluation and assessment of the bids, the Purchaser may request that the bidders provide clarifications regarding their bids.
4. The bidder may alter or withdraw its offer before the submission deadline.
5. Bids submitted past the submission deadline will not be considered.
6. Bids that do not meet the formal requirements set forth herein will not be considered.
7. The Purchaser does not accept variant bids.

8. The Purchaser does not accept partial bids.
9. The Purchaser permits rejecting bids whose essential content clearly raises reasonable doubts.
